4	电池具有适当的防短路措施。 这种设备不会产生危险的放热,在开启状态下符合相关的电磁辐射标准,运行时不会对航空器系统产生干扰,不会发出干扰信号(如蜂鸣警报,闪光灯)。 当同一外包装中含多台设备时,应对设备进行包装并防止与其他设备接触。 Cells and batteries are properly protected to prevent short circuits. These devices are not capable of generating a dangerous evolution of heat. When active, these devices must meet defined standards for electromagnetic radiation to ensure that the operation of the device does not interfere with aircraft systems. The devices must not be capable of emitting disturbing signals (such as buzzing alarms, strobe lights). Where multiple pieces of equipment are packed in the same outer packaging, the equipment must be packed to prevent contact with other equipment.

The information should be shown in the "Nature and Quantity of Goods" box of the air waybill. —Where packages of Section II lithium batteries from multiple packing instructions are included on one air waybill, the compliance statement for the different lithium battery types and/or packing instructions may be combined into a single statement provided that the statement identifies the applicable lithium battery type(s) and packing instruction numbers.

The package must be of such a size that there is adequate space to affix the mark on one side of the package without the mark being folded. Note:The mark illustrated in Figure 7.1.C of the 63rd edition of DGR may continue to be used until 31 December 2026. This requirement does not apply to: —packages containing only button cell batteries installed in equipment (including circuit boards); or—consignments of two packages or less where each package contains no more than four cells or two batteries installed in equipment.
